We reserve the right to suspend or terminate your access to the services for reasons of non-compliance to the T&C.

Women Lift Up (hereinafter 'WLU') provides an Internet website, and organises workshops and events.

Members (hereinafter 'Members') are women, aged at least 18, or considered of age in their State of residence, and sound of mind.

Workshops/classes may be given by non-members (women or men). The latter will hereinafter be referred to as: 'speakers'.

Members may occasionally invite non-members. The latter will hereinafter be referred to as 'guests'.

#### Subscription Form:

To become a Member of WLU, an applicant must fill up the subscription form on the WLU website.

During the subscription process, the applicant declares that she has read and agreed to the T&C.

Subscription fees are paid online.

#### Subscription:

Subscription to WLU is made on a yearly basis and is tacitly renewed from year to year.

WLU reserves the right to change the subscription price and increase its service fees.

A subscription is personal and non-transferable.

Once the form has been reviewed and accepted by WLU, the Member receives an email to set up her private access to the platform.

Members are entitled to a cancellation period lasting 14 days from the submission date of the subscription form. They may exercise their right of cancellation by sending an email to [info@womenliftup.com](mailto:info@womenliftup.com) before the cancellation period expires.

#### Termination and renewal:

Insofar as WLU provides Members with its services and network in real time, a subscription to WLU may not be refunded after the 14-day cancellation period.

Tacit renewal may be stopped upon request to the email address [info@womenliftup.com](mailto:info@womenliftup.com) until 7 days before the yearly subscription anniversary date.

### Services:

WLU provides the following services to its Members:

- **Access to a 'Members' Area on the website after the member has logged in with her personal identifiers.**

Members may create a profile page on the website, including among others their name(s) and first name(s).

Members may publish various contents on their profile, on the Forum or within a group.

Members have the sole responsibility for published content.

The Member is the producer of her content. In no circumstance may WLU be held responsible and the Member is the sole responsible.

WLU offers no guarantee that the content may not be altered.

- **Access to an Application**

A Website App can be downloaded on Apple Store and Google Play Store.

- **Access to IRL or online events and/or workshops organised by WLU**

WLU organises workshops and events led by Members or Speakers.

WLU reserves the right to change its technical support, software, or host, at any time.

### Relations between Members and relations between speakers, guests and third parties:

WLU is not responsible for relations and transactions contracted between Members or between Members and speakers, guests or any other person, even if the Member was directed towards these persons through the Website. In no circumstance shall WLU be party to disputes that may arise between Members, Members and Speakers, guests or third parties.

WLU is not responsible for relations (be they commercial or of any other nature) between Members, Members and speakers and Members and third parties, for instance during workshops, consultations or meetings on the WLU platform.

### Third Party Websites:

WLU declines all responsibility for the service provided by Stripe.

### Applicable law and jurisdiction:

The T&C are under Swiss law.

In case of a dispute relating to the validity, interpretation and/or application of these terms and conditions, the parties agree that the courts of Geneva will have exclusive competence, provided there are no mandatory provisions to the contrary. Right of recourse to the Federal tribunal is reserved.
